## **CONSTITUTIONAL AMENDMENT – STATEWIDE PUBLIC QUESTION # 1**

### **QUESTION**

#### **“SHALL PROPERTY TAXES BE LIMITED FOR ALL CLASSES OF PROPERTY**

by amending the Constitution of the State of Indiana to do the following: ( 1 ) Limit a taxpayer’s annual property tax bill to the following percentages of gross assessed value: ( A ) 1% for an owner-occupied primary residence ( homestead ); ( B ) 2% for residential property, other than an owner-occupied primary residence, including apartments; ( C ) 2% for agricultural land; ( D ) 3% for other real property; and ( E ) 3% for personal property. The above percentages exclude any property taxes imposed after being approved by the voters in a referendum. ( 2 ) Specify that the General Assembly may grant a property tax exemption in the form of a deduction or credit and exempt a mobile home used as a primary residence to the same extent as real property? ”
